All the candidates are requested to visit either of the two above-noted websites and click on the link: "RESULT OF D El Ed PART-I-EXAMINATION-2019-2021" and thereafter, to enter the valid Registration No., Roll and No. in the appropriate space, provided, to obtain their result/status.

The date/s of issuance of the Mark Sheets of the said D. El. Ed. Part-I Examination will be notified shortly.

It is also notified that the scanned copies of Mark Sheets of the Failed/NC candidates, excluding those of the ABSENT (AB) candidates, will be made available online with the heads of the concerned institutes by 4<sup>th</sup> January, 2022. in order to enable them to submit a copy of the same with the application for PPR (Post Publication Review) / PPS (Post Publication Scrutiny) within the stipulated time, preferably within 11<sup>th</sup> January, 2022.

For the purpose of application for PPS/PPR the prescribed PPS/PPR forms will be available with the respective heads of the concerned institution.

- The filled in applications (PPS/PPR) can be sent via e-mail of the concerned D El Ed Institute to [secretarywbbpe.ptti@gmail.com](mailto:secretarywbbpe.ptti@gmail.com) or [wbbpeseecretary.deled@gmail.com](mailto:wbbpeseecretary.deled@gmail.com) only along with the scanned copy of the online transaction details regarding the payment of fees as prescribed & scanned copy of the mark sheet of Part-I-Examination.
- Those who want to submit their filled-in-applications (PPS/PPR) physically within 11<sup>th</sup> January, 2022, shall have to enclose with their applications a Bank Draft, drawn on a nationalised bank in favour of "WEST BENGAL BOARD OF PRIMARY EDUCATION", payable at Kolkata, for payment of prescribed fees and a scanned copy of the mark sheet of Part-I-Examination.
- Necessary Bank details for online transfer of the prescribed fee will be available in the application form for PPS / PPR.

Such NC/Failed candidates, if they come out cleared/passed after PPS/PPR (as the case may be) shall be able to apply online for the Part-II-Examination to be held on and from 27<sup>th</sup> January, 2022 to 29<sup>th</sup> January, 2022, as per our Notification, No. 261/BPE/D El Ed/2021, dated 11/12/2021.

The students who have failed or who remain 'NC' are requested to contact with the heads of the concerned Institution immediately for necessary procedures.
